NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

The replacement of the dilapidated wooden gates between the car-park and the churchyard to the North of the church with craftsman made galvanized and powder coated steel gates in a similar style to those presently serving the South porch of the church. The replacement of the dilapidated soft wood gates at the Lych Gate between the churchyard and the adjacent field to the west of the church using untreated oak in a style replicating the present gates. The repair to one structural beam of the Lych Gate using similar materials and a galvanized and powder coated steel plate. In accordance with Neil Lossock quotation and design 2 dated 13th September 2019; Statements of Significance and Need; Traditional Joinery (David Malone) quotation dated 14th May 2019; PCC Minutes dated 14th May 2019 and EIG approval dated 21st February 2020.

#### Directions to petitioner
